### **3. BONUSSES (Applicable to all Strategic Operators)**

#### **A. Consideration**

Strategic Operators \* are considered those who, due to their ability to move goods, are essential in maintaining the objectives of the ZFS. They exclusively receive this strategic status, due to the movement figure in volume of tons.

#### **B. Volume and amount (on Tariff G exclusively)**

From 25.000 tons. to 50,000 tons. year	2% Bonus
from 50,001 tns. to 75,000 tons. year	2.5% Bonus
+ of 75,000 tns. year	3% Bonus

#### **C. Form of application**

It will be applied in the form of credit to the operator's account, in the first fortnight of the first month of the calendar year.

#### **4. CONDITIONS to operate**

1. The Operator of the ZFS facilities must complete the ENTRY APPLICATION, a document where he accepts the general conditions and the current price list.
2. The Operator of the ZFS facilities is responsible for the damages, losses and losses in the merchandise that are derived from their nature, and / or from the damage in them not observable at the time of entry into the ZFS.
3. ZFS has a Civil Liability Insurance, with a prestigious company, for a maximum value of 2,000,000.- euros, to deal with claims on merchandise derived from events attributable to the ZFS itself and its employees, including ; theft, fire and natural causes. This insurance does not cover deterioration or loss derived from the condition of the nature of the goods.

#### **5. EXCEPTIONS (not included in the general rate)**

By virtue of the agreement of the Plenary of the ZFS Consortium, it corresponds to the Special Delegate of the State, the approval of the rates corresponding to the services provided in the ZFS not expressly included in these rates, for which calculation the philosophy of the general rate must be applied.

To do this, you must take into account values such as:

- a. Volume
- b. Specific weight
- c. Density
- d. Average value of merchandise
